With the aim of strengthening Kosovo's democracy, BPRG published the "Women in Politics: Gender (In) Equality in Politics and Decision-making" policy article that reviews the unfavourable position of women in politics and governance of the country. The article identifies aspects which maintain the massive gap of gender inequality in Kosovo and provides concrete recommendations for improving gender equality in the country's political life and governance.

The policy article on Women in Politics provides an in-depth analysis on the necessity for integrating gender mainstreaming as a cross cutting characteristic in the change of policies. It highlights the need for gender budgeting in all areas, and the participation of women in public consultations. The article provides clear recommendations that should be followed by institutions and political in order actors, gender-mainstreaming be standardized.

This policy paper presents data on women's representation local in institutions and enterprises. Following the deep gender gap in politics and governance at the central level, an underrepresentation of women is evident at the local level as well, where men hold all but a few leading positions. The numbers that show the massive gender gap in all municipalities are a call for concern and immediate action. Due unsatisfactory situation, the report also offers recommendations on the legal changes that are much needed and other affirmative measures that must be taken.

## Outreach and Promotion Activities

Balkans Group's strategic initiative to promote gender representation has significantly impacted a broad audience through various channels, including websites, social media, and media outlets. Our activities, encompassing web posts, live streams, social media posts, video compilations, events, press releases, and media interviews, effectively raised visibility and fostered discussions on crucial societal issues. This outreach extended to policy articles, with over 1,000 copies printed and distributed through workshops and roundtables and provided to key institutions such as the government, the President, parliament members, independent institutions, the Ombudsperson, and donors.

#### Campaign for changing the quota

The "A Call for Change" campaign is a cornerstone of our efforts, which aims to increase women's political representation and align the General Elections Law with the Gender Equality Law. Our research highlights women's challenges in securing political and institutional roles, underscoring the urgent need to close the gender gap. To overcome these challenges, this campaign mobilized prominent figures, including Prime Minister Albin Kurti, MPs, assembly members, leaders, political party representatives, NGOs, donors, and other social actors.

The policy dialogue event was organised to discuss and enhance the women inclusion in politics, institutions and decision-making on the basis of the findings of the BPRG's recent Policy article "Women in Politics – Gender (In) Equality in politics and decision-making".





## Consultation meetings with Women Caucus and Municipal Assembly Members – December 2019 – February 2020

6 consultations meetings were organised of the Women Caucus Delegation with Municipal Assembly Members, Gender Equality Officers and other relevant stakeholders to discuss the challenges, lessons learned, limitations and future endeavours of the yearly work-plan as well as the needs and challenges regarding gender issues. These consultation were held in 6 major municipalities in Kosovo.

The training was designed to equip women decision-makers with the necessary tools to increase their online presence and establish better communication with the public through social media.

### Dialogue round-table with women MPs - 29 March 2018

BPRG organized a round-table with women MPs. Gathering the board members of women Caucus and the chairwomen of parliamentary commissions, the round-table discussion was framed around the role of women MPs in the political dialogue. Present at the round-table were women from all major political parties and a representative from the US Embassy in Kosovo.

#### **Advocacy Letters**

Following the publication of the policy article, "Women in Politics – Gender (In) Equality in politics and decision-making, Balkans Group has sent advocacy letters to various institutional leaders including the prime minister, President of the Kosovo Assembly, heads of parliamentary groups and parliament members, political party leaders and the Kosovo-Serbia Dialogue Team, to advocate and promote the enhancement of gender equality, and the quota and also address the following recommendations:



Appoint more women to the presidency, parliamentary committees, and other bodies of the new Assembly;

Increase the number of women in leadership positions in Government, agencies, boards, and other government institutions;

Undertake additional actions to advance the implementation of the Law on Gender Equality in public institutions.

Balkans Group's initiatives to promote gender equality in Kosovo have demonstrated a substantial impact across multiple dimensions. Our efforts, from policy advocacy to extensive outreach campaigns, highlight the urgency of addressing the gender gap in politics and decision-making roles.
